DEPARTMENT OF CHILDREN AND FAMILIES REGIONAL SCHOOL TUITION CONTRACT AGREEMENT

AGREEMENT dated this 26th day of July, 2011, between the Brick Township Board of Education, in the County of Ocean and the State of New Jersey (hereinafter referred to as the "SENDING DISTRICT", and the New Jersey Department of Children and Families, Office of Education (hereinafter referred to as the "RECEIVING DISTRICT").

WITNESSETH

NOW, THEREFORE, in consideration of the covenants herein contained, the parties agree as follows:

- The SENDING DISTRICT agrees to purchase educational services from the RECEIVING DISTRICT. The RECEIVING DISTRICT agrees to provide educational services to the SENDING DISTRICT in accordance with the applicable New Jersey Statutes and the rules and regulations of the State Board of Education. The specific educational services described in "1a" below are being purchased and provided for the student(s) listed below:

- 1a. For each of the student(s) listed above, the RECEIVING DISTRICT agrees to provide educational services in accordance with the student's Individualized Educational Program (IEP).
2. This AGREEMENT shall be in effect for the **2011-2012** school year. The educational services shall commence on July 1, 2011.
3. The per diem rate for each enrolled student is \$177.27. The RECEIVING DISTRICT provides 220 contact days. The New Jersey Department of Education shall withhold the annual tuition from the state aid of the SENDING DISTRICT. Annual tuition will be paid to the RECEIVING DISTRICT by the Department of Education.
4. In the event a student is discharged during the school year, the SENDING DISTRICT will receive a partial refund of the annual tuition cost from the Department of Education. The refund will be based on a per diem charge of \$177.27 for each student contact day.
5. In the event any dispute arises out of this AGREEMENT, the parties will seek to resolve the dispute as expeditiously as possible. Except as may be set forth herein, the interests of the student(s) shall be of the foremost concern in resolving such disputes.
