
DOROTHY PIETRUCHA, M.D. HEREBY STATES:

Additional persons may subsequently be included as participating Principals, but only if acceptable to the Board. Dorothy Pietrucha, M.D. declares that this Proposal Statement is made without connection with any other person, firm or parties who has submitted a Proposal Statement, except as expressly set forth below and that it has been prepared and has been submitted in good faith and without collusion or fraud.

5. Dorothy Pietrucha, M.D. acknowledges and agrees that the Board may modify, amend, suspend and/or terminate the procurement process (in its sole judgment). In any case, the Board shall not have any liability to the Respondent for any costs incurred by the Respondent with respect to the procurement activities described in this RFP.
6. Dorothy Pietrucha, M.D. acknowledges that the provision of Pediatric Neurology Consultations must apply with all applicable affirmative action and similar laws. Respondent hereby agrees to take such actions as are required in order to comply with such applicable laws.
7. Dorothy Pietrucha, M.D. submits a proposal for fixed fees, including out of pocket expenditures, as follows:

10. Dorothy Pietrucha, M.D. agrees that the services are being delivered and are intended to be performed in the state of New Jersey and shall be constructed and enforced in accordance with the laws of that state.
