5. ADVANCE Education Advisement acknowledges and agrees that the Board may modify, amend, suspend and/or terminate the procurement process (in its sole judgment). In any case, the Board shall not have any liability to the Respondent for any costs incurred by the Respondent with respect to the procurement activities described in this RFP.

6. ADVANCE Education Advisement acknowledges that the provision of [insert services] must comply with all applicable affirmative action and similar laws. Respondent hereby agrees to take such actions as are required in order to comply with such applicable laws.

7. ADVANCE Education Advisement submits a proposal for fixed fees, including out of pocket expenditures, as follows:



9. ADVANCE Education Advisement agrees to defend, indemnify and hold the Brick Township Board of Education harmless with respect to any claim for injury to person or property arising out of acts of ADVANCE Education Advisement, its subsidiaries, parents, agents, principals or employees.

10. ADVANCE Education Advisement agrees that the services are being delivered and are intended to be performed in the State of New Jersey and shall be constructed and enforced in accordance with the laws of that State.
