

TUITION CONTRACT AGREEMENT

AGREEMENT dated this 15th day of July, 2020, between the Brick Township School District Board of Education, in the County of Ocean and the State of New Jersey (*hereinafter referred to as the "SENDING DISTRICT"*), and the Ocean County Vocational Technical School Board of Education, in the County of Ocean and the State of New Jersey (*hereinafter referred to as the "RECEIVING DISTRICT"*).

WITNESSETH

NOW, THEREFORE, in consideration of the covenants herein contained, the parties agree as follows:

- 1. The SENDING DISTRICT agrees to purchase educational services from the RECEIVING DISTRICT. The RECEIVING DISTRICT agrees to provide educational services to the SENDING DISTRICT in accordance with the applicable New Jersey Statutes and the rules and regulations of the State Board of Education. The specific educational services to be purchased and provided are described in 1a. below.
 - 1a. The specific educational services described in this section or attached as an appendix to this AGREEMENT are to be provided for the resident pupils in grades 9 through 12 the SENDING DISTRICT.
 - 1b. The SENDING DISTRICT hereby agrees they are responsible for any special education or related service costs, which are not included in the tuition for the programs set forth in paragraph 1(a) above.

Sending District agrees to send and Receiving District agrees to receive the attached named student (s) who will be enrolled in the programs listed. Sending District agrees to pay tuition in the following amounts for the listed programs at \$765.00 per shared time student, and \$1,530 for academy students.

- 2. This AGREEMENT shall be in effect for the 2020 - 2021 school year. The educational services shall commence on September 2, 2020 and terminate on June 16, 2021.
- 3. Tuition charges, as part of this AGREEMENT, as well as the payment of same shall be made in accordance with the applicable New Jersey Statutes and the rules and regulations of the State Board of Education.
- 4. In the event that a student drops during the school year the determining factor will be the drop date. If a student drops prior to the 15th of the month no tuition will be charged for that month. If the drop date is the 15th or later, full tuition will be charged. Invoices will be sent out at the beginning of each month for the previous month with the aforementioned adjustments.
- 5. In the event any dispute arises out of this AGREEMENT the parties will seek to resolve the dispute as expeditiously as possible. Except as may be set forth herein, the interests of the pupil(s) shall be of the foremost concern in resolving such disputes.

IN WITNESS WHEREOF, the parties have caused this AGREEMENT to be duly executed as of this 1st day of September, 2020.
