All invoices are due within 15 days of submission or a finance charge of 1% per month (12% per annum) shall be applied to any outstanding amount owed. Owners shall be responsible to the Contractor for all costs and fees associated with the collection of payment of any outstanding invoices, including, but not limited to, costs of suit and reasonable attorney fees in the amount of fifteen percent (15%) of the total unpaid balance due or the fees actually incurred, whichever shall be made by Contractor. If owners decide not to have Contractor perform permanent repairs after an estimate has been prepared, owners will pay Contractor an estimating fee of 2% of the overall total on the repair estimate.

4. TIME FOR PERFORMANCE:

Work shall begin by 12/5/13 (Date), and shall be completed within ~~_____ (# of days)~~ ~~calendar days of that date~~. Contractor shall not be liable for any delay or nonperformance caused by an act of God, strikes, unavailability of supplies or materials, unavoidable casualties, or any other cause beyond its control. Work may begin immediately if required to meet a bona fide emergency of the Owners.

5. CONTRACTOR'S INSURANCE:

Contractor hereby represents that it maintains a commercial general liability policy in a minimum amount of \$1,000,000.00 per occurrence. A copy of the insurance certificate, including the telephone number for the insurance company and/or agent, will be supplied upon request.

6. WARRANTIES:

Contractor shall furnish the Owners with a copy of all guarantees or warranties with respect to applicable labor services and materials furnished by the Contractor in connection with the execution of this Agreement, if any.
