

TUITION AGREEMENT

The Marie H. Katzenbach School, Division of Direct Services, New Jersey Department of Education, agrees to accept, and the *Brick Twp.* Board of Education agrees to send [REDACTED] as a student at the Marie H. Katzenbach School for the Deaf during the 2015 - 2016 School Year. The *Brick Twp.* Board of Education agrees to pay to the Katzenbach School tuition for the School Year 2015 – 2016 based upon a rate of \$74,121.00 per year in educational charges for the *Multiply Disabled Program*.

**Both parties agree that the New Jersey Department of Education shall withhold the tuition from the state aid of the district.**

It is understood by both parties involved in this agreement that there will be an adjustment of the tuition obligation for enrollment less than the full academic year of 181 days. Such adjustment will be based upon a per diem rate computed at 1/181 of the annual rate.

This AGREEMENT may be terminated by the SENDING DISTRICT or by the KATZENBACH SCHOOL upon 15 calendar days written notification to the other party.

If the SENDING DISTRICT does not provide adequate notification according to N.J.A.C. 6A:14-7.7 (b), the KATZENBACH SCHOOL may add the number of enrolled days within the 15 calendar days notification period so that the tuition charged the SENDING DISTRICT reflects compliance with the 15 calendar days notice requirement. (Example: SENDING DISTRICT provides five calendar days notice; the KATZENBACH SCHOOL may add the additional number of enrolled days within the next 10 calendar days for the purpose of determining the tuition due. The additional enrolled days billed must be reflected on the New Jersey School Registers as enrolled days.)

If the KATZENBACH SCHOOL does not provide adequate notification according to N.J.A.C. 6A:14-7.7 (b), then the SENDING DISTRICT is only responsible for tuition up to and including the pupil's last day of attendance.

The KATZENBACH SCHOOL upon five consecutive daily absences by this pupil agrees to notify the SENDING DISTRICT so that the SENDING DISTRICT may investigate the enrollment status of this pupil. If the SENDING DISTRICT discovers enrollment has ceased, they shall be responsible for tuition for the number of enrolled days within the 15 calendar days notification period after written notification of termination has been given to the KATZENBACH SCHOOL. If the KATZENBACH SCHOOL does not notify the SENDING DISTRICT upon five consecutive daily absences by this pupil, the KATZENBACH SCHOOL waives their right to tuition beyond the five consecutive daily absences if the pupil does not return.

The LEA designates the MKSD Superintendent as an authorized individual for determining access to pupil records. Access will be granted in accordance with N.J.A.C. 6:3-6.5.

The tuition charge agreed to herein is based upon an initial enrollment date of 9/8/15.


