AGREEMENT dated this 16th day of November 2015 between the Brick Township Board of Education, in the County of Ocean and the State of New Jersey (*hereinafter referred to as the "SENDING DISTRICT"*), and Somerset County Educational Services Commission Board of Directors, in the County of Somerset and the State of New Jersey (*hereinafter referred to as the "RECEIVING DISTRICT"*).

NOW, THEREFORE, in consideration of the covenants herein contained, the parties agree as follows:

1. The SENDING DISTRICT agrees to purchase educational services from the RECEIVING DISTRICT. The RECEIVING DISTRICT agrees to provide educational services to the SENDING DISTRICT in accordance with the applicable New Jersey Statutes and the rules and regulations of the State Board of Education. The specific educational services to be purchased and provided are described in 1a. below.
- 1a. The specific educational services described in this section or attached as an appendix to this AGREEMENT are to be provided for the resident students in grades 9 through 12 from the SENDING DISTRICT.

The Somerset Secondary Academy–Alternative Academic Program is an alternative high school program operated by the Somerset County Educational Services Commission. Course requirements, proficiencies and competencies shall be those of the SENDING DISTRICT.

The following student will attend the Somerset Secondary Academy–Alternative Academic Program:

2. This AGREEMENT shall be in effect for the 2015–2016 school year. The educational services shall commence on November 16, 2015 and terminate on June 30, 2016.
3. Tuition charges, as part of this AGREEMENT, as well as the payment of same shall be made in accordance with the applicable New Jersey Statutes and the rules and regulations of the State Board of Education.
4. The SENDING DISTRICT agrees to pay **\$2,815.00 per month**, prorated from the enrollment date/termination date, commencing 30 days after receiving an invoice from the RECEIVING DISTRICT.

The SENDING DISTRICT will pay any amount owed to the RECEIVING DISTRICT in accordance with the following payment schedule:

\$28,150.00 Annual Tuition (\$2,815.00 monthly), due by the 30th of the following month.

5. In the event it becomes necessary for the SENDING DISTRICT to request that the county superintendent waive the payment schedule in 4. due to hardship, the SENDING DISTRICT will immediately notify the RECEIVING DISTRICT of such request.
6. The RECEIVING DISTRICT agrees to provide the SENDING DISTRICT with a monthly tuition bill and a monthly report showing pupil enrollment and attendance.
7. In the event any dispute arises out of this AGREEMENT the parties will seek to resolve the dispute as expeditiously as possible. Except as may be set forth herein, the interests of the pupil(s) shall be of the foremost concern in resolving such disputes.
